- ~ A distribution reinvestment plan will be available.

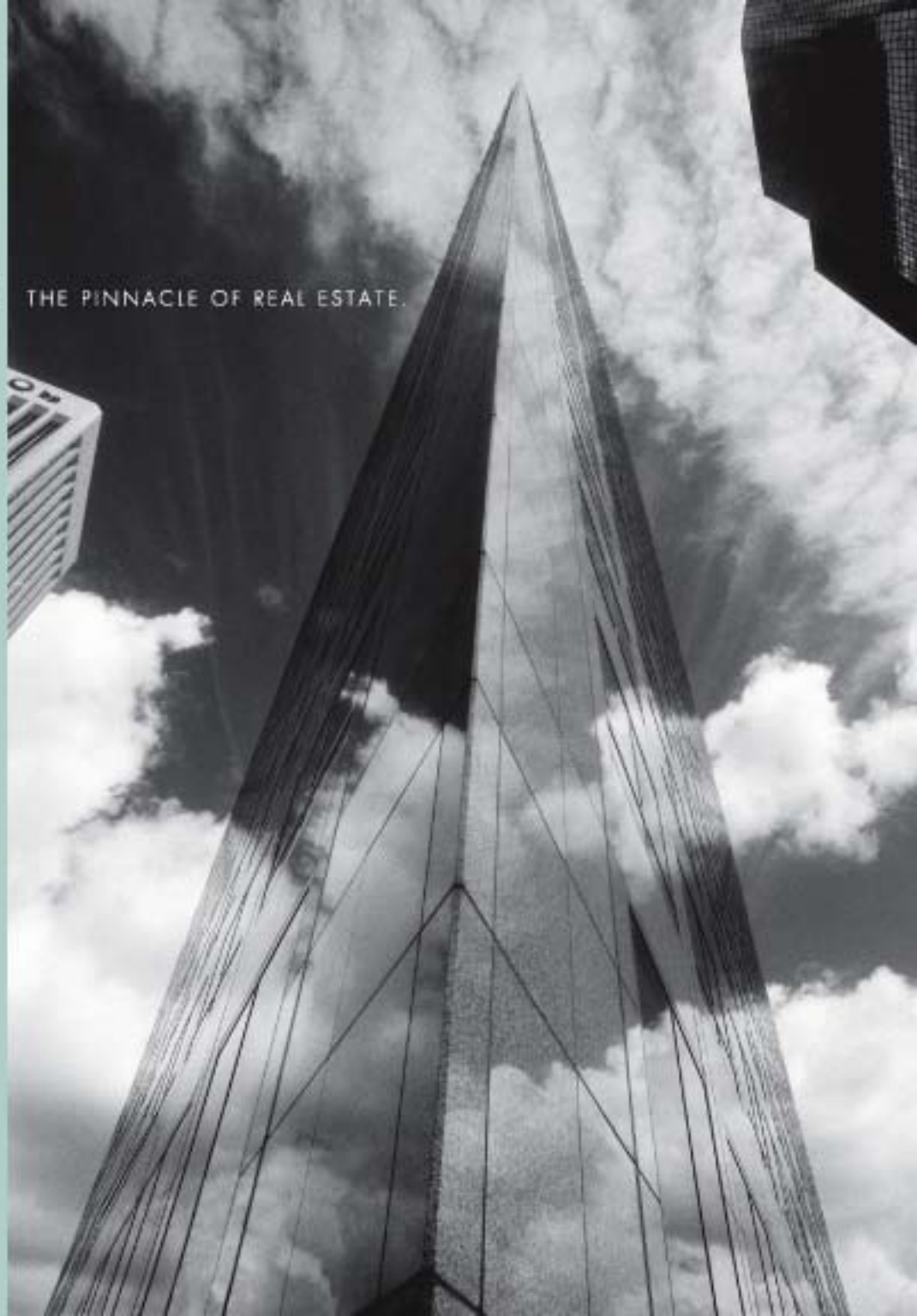
Fund Specifics

- ~ A private real estate equity fund.
- ~ Initial equity will be \$250,000,000 (U.S.).
- ~ Minimum investment is \$1,000,000 (U.S.).
- ~ Interested parties must meet all requirements of an accredited investor under applicable securities laws.
- ~ The fund will have an indefinite life.

Limited Liquidity

- ~ Periodic redemptions subject to annual limits and a one year holding period.

Investment Objectives

- ~ Preserve invested capital.
- ~ Invest in a well constructed portfolio of Class A office, retail, mixed use and industrial properties with credit or similar high quality tenants in desirable locations and business climates while providing an investment strategy that is both flexible and diversified in nature. Such investments will be made primarily in Sunbelt locations within the United States.
- ~ Pay regularly scheduled distributions.
- ~ Position the assets for an appreciation in value.
- ~ Remain a private real estate equity fund.

Target Investments

- ~ The purchase and/or development of Class A office properties located in central business districts and suburban markets of large metropolitan areas.
- ~ The purchase and/or development of high quality retail properties in areas experiencing significant population and employment growth.
- ~ The purchase and/or development of visionary mixed use properties in desirable metropolitan areas.
- ~ The purchase and/or development of high quality industrial properties in areas that have significant domestic and international trade components and quality transportation infrastructure, as well as those areas around major air freight "hubs".
- ~ The Fund may invest in ground leases and other specialized real estate investments.



Investment Philosophy

A Conservative Investment Approach

- ~ The Fund's investment philosophy will be guided by the principles of conservatism coupled with creative thought.
- ~ All potential investment opportunities will be analyzed and evaluated using conservative measures to predict future cash flows, which ultimately determine the value of an asset.
- ~ The Fund's Management believes that comprehensive due diligence, including physical property inspection and detailed market analysis is paramount in decision making.
- ~ The Fund will perform assessments of "unseen opportunities" while at the same time addressing potential problem scenarios in order to consistently structure a successful real estate portfolio.
- ~ The Fund will utilize conservatively leveraged, appropriately placed debt in order to maximize investor returns. Kerioth's excellent relationship with numerous prominent financial institutions makes it possible to obtain financing arrangements with superior terms.

The Kerioth Pinnacle Fund will seek to purchase and/or develop assets having the following attributes:

- ~ Preferred Location - This attribute has the greatest impact on an asset's long term income producing potential, and thus the fund will invest in the preferred sub markets of metropolitan areas.
- ~ Superior Physical Characteristics - Properties that have superior design and physical characteristics (e.g. quality construction and state of the art building management, energy efficiency and control systems).
- ~ Quality Tenants - Properties that attract and retain strong credit tenants.

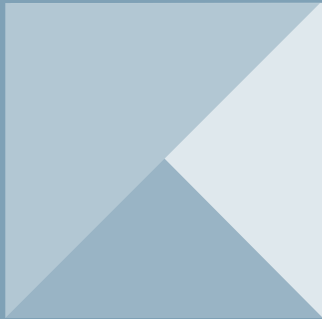

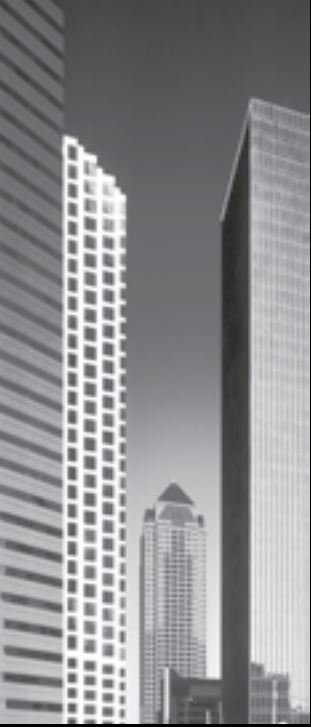
